

**Substitutive declaration of a notarial deed on the non-existence of the causes of non-conferability and incompatibilità, pursuant to Legislative Decree no. 39 of 8 April 2013, amended by Law n. 98 of 9 August 2013
(pursuant to art. 46 and 47 D.P.R. 445/2000)**

- not being in the causes of incompatibility, pursuant to art. 12 of Legislative Decree 39/2013;
- not being in the causes of incompatibility, pursuant to art. 13, paragraph 2 and paragraph 3 of Legislative Decree 39/2013.
